OTHER

NorthantsCALC – note their advice is to continue with virtual meetings for the time being.

SNC Register of Interest forms – Councillors are reminded to check that all their details are correct on the SNC website and to submit a new form to the Clerk if necessary.

Projector Screen – this has been delivered to the Village Hall. The Committee has advised that they intend to move the acoustic screen and install the projector screen beneath it.

Two blocked drains reported by Cllr Wickham have been logged with NCC – reference **2178901** and **2178914**.

Planning: note that application S/2020/0823/AGD at Poplars Farm Wappenham Towcester NN12 8SU received as for information only since the last meeting has already been determined and requires approval due to the potential visual aspect of the proposal.

Clerks’ Pay Award – the employers' side of the negotiations on local government salaries has confirmed that its previous offer of an increase on 2.75% plus a one-day increase in annual leave is the final offer. The Unions are consulting members on this and so no further news is expected until the end of August, On this basis the clerks’ salary on the bills for payment (**Agenda Item 6.1**) has been calculated at the same rate as last year until a retrospective pay increase is announced.
